A BUSY ENDING TO 2013

2013 had its share of success and failures; there were some lofty goals achieved and some goals not quite attained. We said goodbye to some close friends and loved ones and welcomed new members to our veteran community. "News and Views" covered the year and was rewarded with national and state VVA recognition. The year ended well with some notable events.

On the 17th of December, after the regular Vet Connect Clinic, veterans were treated to an East Indian meal served by the Santa Rosa Sikh Temple. Members of the local Sikh temple treated vets to hot fresh naan bread, rice, yogurt and vegetarian dishes. Veterans, some of them homeless, took part in the annual event at the Santa Rosa Veterans Memorial Building. A jazz band played as volunteers from the Sonoma County Veteran Community provided veterans in need with donated clothing and toiletries. Homeless vets were given new long johns, socks, tarps and back packs provided by The Purple Heart Chapter 78.

Dr. Mandeep Nagra, the primary organizer of this event, is a member of the Sikh temple off Todd Road and a physician at the Santa Rosa VA outpatient clinic. Dr. Nagra said, "It's a longstanding tradition for Sikhs to cook for themselves and their fellow temple members." Their reaching out

to the homeless is an extension of that tradition and an example of our diverse community helping itself. This annual winter event is held when the homeless are most vulnerable to the cold weather and the elements.

In Healdsburg, a group of volunteers got together in the gym at St. John's Catholic School to pack more than 280 decorated boxes bound for soldiers serving in Afghanistan this past holiday season. The community-wide event was directed by Mary St. Clair, creator of Healdsburg SOS (Supporting Our Soldiers), and was done with the help of VVA Chapter 223, local businesses, service clubs, and police and fire departments. The highlight of the packing party was a Skype conversation with some of the soldiers in Afghanistan. The base commander, Lt. Col. Brad Wambeke, and members of his staff shared in a conversation with the volunteers in Healdsburg from a conference room in Kandahar Provence where it was just before 8 a.m. the next morning. Thank you, Mary St. Clair, and all those that participated in this show of community support for our troops. (See pictures on page 5)


It is a new year, and I hope everyone is doing well. It has been quite a while since my last report. The chapter is still active in many things and working on expanding our involvement in some of them. I have asked that the board members put their goals for this year in our newsletter. I am also asking that our members let us know what your goals might be for us as your board.

We will be working a lot on communication this year. With the changes going on in the world, today we can send messages and information to a lot of people very quickly. Although a lot of our members are not plugged in, there are a lot that are. We would like to do a lot of updating our web page this year and make it a place where people can go to see what we are doing next week or next month. I am looking for members to assist with our communication tools. We have a great newsletter. We need to move our web page to the same level. To do this we need to incorporate video into the page and have consistent updates made to it. There are many ways that you can assist. We have been compiling an email list and we would like to know if you would like us to alert you with updates on chapter projects. I know that I need reminders more often that in the past.

We have had a bill introduced into the U.S. Senate by Senator Blumenthal from Connecticut. This legislation is what we have been working on for years to get research into intergenerational effects of toxins in the military. Senate Bill, S 1602 "Toxic Exposure and Military Support Act of 2013" needs all of us to contact our Senators and ask that they support it. I have heard back for both and I am not happy with their responses. They wish to wait for the bill to come out of committee, I wish for them to co-sponsor the bill now. Please download this bill and write to your Senators and encourage them to support it and our children.

On the state level we will be holding our state convention in June in Fresno. I am the elections committee chair and am looking for people to run from state office. We will have at least six delegates attending the convention. Since I will be running the elections I will not be a delegate or a candidate. I still serve as the state legislative chair and the new year will mean more trips to Sacramento to meet with our legislators. Our state legislative day is set for March 26th. We will also be celebrating Welcome Home Vietnam Veterans Day at the Vietnam Memorial. Stay tuned for more information on this.

We will be planning to work the Wednesday night market in Santa Rosa this year. Last year we worked part of it and it was very successful as a way to inform people of veteran issues and tell them about our chapter. I will be looking for members to assist on this since it will 3 take up 16 Wednesday nights.

WOMEN VETERANS COMMITTEE REPORT

National Board Meeting, January 2014

Last week I went back to Silver Springs, Maryland for the National VVA Board Meetings. It was the second meeting that I have attended since taking over as the National Women Veteran Committee Chair. This is truly a whole other level of veterans working to help veterans. They are sincere and determined. While there, I attended the PTSD/SA committee meeting, the Homeless Veterans Committee, and the Government Affairs Committee.

Each committee does post their minutes of the meeting on the national VVA website. It is quite amazing what is going on at the national level. Dr. Tom Hall, PTSD/SA chair, currently serves on the Director's Focus Group at the Kansas City, Missouri, V.A.M.C. The committee is continuing to update the PTSD/SA brochures, a proposal for the 2014 leadership conference, and have members continue local community educational outreach efforts, especially Re: suicide prevention. The committee co-sponsored the second MST workshop in partnership with Service Women's Action Network (S.W.A.N.) They also developed a workshop to help non-veterans better understand the values and training of serving in the military.

Dr. Hall stressed the importance of joining into your local VAMC's director's meeting to relay any concerns that veterans have concerning their care. John Crooker represents us at the San Francisco VAMC meeting monthly. If you have concerns, you need to let John know. Next month, I will give an overview of the Homeless Veterans Committee. If you read last month's Veteran, you will see the hard work that Sandy Miller has spearheaded in this area.

Women Veterans Committee meeting discussed the end of the year passing of the DoD budget and the lack of passage of both Senator Gillibrand's and Senator McCaskill's bill on MST issues. There is a deadline of August, 2014, to implement the measures included in the DoD budget bill regarding changes to the handling of MST cases.

We also had the DoD Sexual Assault Prevention and Response Annual Report on Sexual Harassment and Violence at the Military Service Academies for review. Secretary Hagel is directing the Secretaries of the Military Departments to enhance their respective Academy programs through several prevention and response strategic plans. They will also review and expand the institutional alcohol policies as a result of findings that alcohol is linked to most assaults.

A new brochure for MST was suggested to be made by the committee.

The longitudinal study on Women veterans who served during the VN era is due out this year. Two reports are in for publication review now. I will keep you posted when the findings are available and I hope to have one of the researchers speak to the committee this year.

March is Women's History month and committee members as well as all VVA chapters are encouraged to participate in their local community events. Tammy Duckworth, Illinois 8th Congressional District Representative and former Blackhawk pilot during OIF, is an awardee in this year's National Women's History Project.

Santa Rosa Quilting Guild and AVVA

There are several ladies from the Santa Rosa Quilting Guild that I have met recently. Over the past few months they have made a huge difference in many Veterans' lives.

The first time I met LaVella, Mirna and Karen they gave me 9 quilts, all about twin bed size, and 20 wheel chair bags. I turned 8 of them over to the VA Clinic and the Director of the homebound Veterans program. The quilts flew out the door, as well as all the bags that very first day.

My husband John took one of the quilts to the hospital for one of our own VVA chapter members. He told me he slept on top of it the first night then gave it to his sister to take home. That's how much he loved it and was afraid of it being stolen!

The next time I met with 'The Quilters' they gave me 16 lap quilts which I again took up to the VA Clinic. We divided them between the homebound Director and the prosthetics department, making sure they made it into the hands of Veterans in wheel chairs.

Since that first meeting they have been making quilts at a fast pace. At least every other week I get a call from them to pick up more.

In December, when we had that freezing weather, The Quilters brought in 40 fleece blankets. 25 of them went to the Hearn and Rocha Veterans homes. The Director there said the rooms are so dull and generic that the blankets would really brighten things up. The rest of the blankets we distributed between the homeless shelter and the Rescue mission.

The week before Christmas I met another Quilting Guild member, Leslie, who gave me 30 knitted scarves and hats. I set up a table outside the clinic and gave them out there. By noon they were all gone. One Veteran told me that now he has a Christmas present for his daughter.

They haven't slowed down any either. They continue to make quilts, wheel chair bags, bags for walkers along with hats and scarves.

The Clinic has an orientation class for wheel chair Veterans. They have been handing out the quilts and bags there, as well as to anyone who rolls in for an appointment

The Quilters are so excited and committed to making sure their quilts get into the hands of Veterans. I am very glad they found me, and that I am able to distribute them into the Veteran community and help them meet their goals.

Every January your VVA 223 sends out scholarship applications to all the high schools in Sonoma County plus Sonoma State, Santa Rosa JC, and Empire College. The funding for these scholarships comes from the efforts and fund raising of all the members of VVA 223 throughout the year.

The scholarship forms get mailed to the scholarship coordinators of the respective schools in our county. The requirements for the high school and college students are that they are a child or a grandchild of a Vi-

etnam Era Vet. The applicants will be graded on grade point, academics, community service, and a 500-word essay on, "What effect did my parent's or grandparent's military service have on my life."

There is a category for college students who have recently served in the military in Iraq and/or Afghanistan. They will also be graded on academics and grade point average and will need to provide a 500-word essay on, "What effect did my military service have on my life."

Last year we presented 3 scholarships for \$1,000.00 each, one to a student at Petaluma High School, and two to vets attending Sonoma State and Empire College.

We will have applications available to VVA223 members who would like to give an application to any of their children or grandchildren that meet the above requirements. If you are interested in participating, you should let someone in the Chapter leadership know. Let's help make 2014 a good year for veterans in our community, state and country.





Volunteer seeks photos of Sonoma County soldiers who died in Vietnam

Volunteers who are collecting photographs of the U.S. servicemen who died in Vietnam have issued the names of five Mendocino County men whose pictures still are needed for inclusion in an Education Center being constructed alongside The Wall in the nation's capital.

Creators of the Vietnam Veterans Memorial Education Center hope to acquire and display photos of each of the more than 58,000 Americans lost to the war in Southeast Asia.

Volunteer Janna Hoehn of Hawaii said the Mendocino County servicemen whose photos still are needed are:

Donald G. Armstrong, Ukiah; Charles E. Crain, Redwood Valley; Robert M. Lathrope, Mendocino; Lewis L. Short, Covelo; Jeffrey S. Wesolowski, Ukiah.

Hoehn said volunteers with the Vietnam Education Center have acquired photos of all of the serviceman from Lake County who died in Vietnam. But she still is looking for pictures of nine Sonoma County men who were casualties of the war. They are: John N. Brewer, Sonoma; Rickie D. Fisher, Santa Rosa; David L. Harding, Rohnert Park; Jason D. Hunnicutt, Petaluma; Ronald D. Marcrum, Monte Rio; William E. Montgomery, Healdsburg; Cameron A. Rice, Petaluma; Dana G. Rose, Santa Rosa; Jerry D. Schroeder, Santa Rosa.
