

# **EDD and Veterans Organizations Host Job Fair for Sonoma County Vets**

There were 58 employers looking to fill nearly 1,500 jobs. There were close to 1100 job seekers in search of employment opportunities and more than 20% (240) were veterans. In Sonoma County, veterans have a higher unemployment rate than nonveterans. In 2011 the five-year average for unemployment among veterans was 9.7 percent compared to 8.4 percent among nonveterans, according to EDD.

On hand were 26 veterans' resources organizations to assist the job seekers. Vet Connect and Chapter representatives from five local veterans' organizations were there giving important information and help. The CALVET Center's Mobile RV was located outside and saw 150 veterans, of which 90 were combat vets.

Claudio Calvo, the EDD Veterans' Rep. and a Vietnam Vet himself, has organized this event for the last two years.

His ideas and efforts have been the driving force behind the enormous success of these job fairs in Sonoma County. Claudio has worked very hard to ease the burden felt by veterans re-entering our community. Finding employment and having access to veterans' resources goes a long way to helping returning vets maintain dignity and self-respect. Claudio has a second job fair planned later on this year at the Double-Tree Hotel in Rohnert Park.

The day began with the presentation of the colors. Local veterans' organizations and representatives of all five branches of service took part in the ceremony. Congressman Jared Huffman presented the job fair organizers with a certificate from the U.S. Congress. There were other politicians on hand, including representatives from two Assembly offices and one State Senator's office. The Sonoma County Board of Supervisors presented Claudio and the fair organizers with a Gold Resolution for their achievement. Also attending was the Secretary of the California Department of Veterans Affairs Major General Peter Gravett (Retired).

Although the veterans' resource and job fair was organized to help veterans find work and get the help some of them so

#### CALIFORNIA STATE COUNCIL MEETING - MAY 4, 2013

The CSC meetings last week in Fresno were filled with information. It was a great time to get together to hear how the other chapters are doing.

Our guest speaker, Charles Hunnycutt, is a veterans service officer in Fresno and Madiera. He shared the history and current situation with the CDVA. There are 56 service officers in California. The advantage of a veteran using a service office to put in their compensation claim is many. They have three trainings per year, they get a national accreditation and then can loop with six different veterans associations for current information, and they now work to develop fully developed claims before they are submitted. This all helps to shorten the length of time of claim adjudication. The lack of funding per county is what determines how many service officers you may have in your community. The state only funds 15% of each office and the county funds the rest. It is up to the veterans in each community to go to the county board of supervisors to get each office the increase in funds they may need for functioning.

Karen Olzewski, our very own VVACSC service officer in Long Beach, reviewed the current status of veteran claims from her point of view. She reminded those of us who are ready to join the Social Security ranks that your military service is calculated in to enhance your Social Security monthly check. Don't forget to mention that. The 526EZ compensation claim form is a newer form that is only 2 pages long and takes three to six months to process. If you are interested in submitting a compensation claim, it is important to have your doctor fill out a Disability Benefits Questionnaire (DVQ) to help support your physical claims. Again, she reminded us that PTSD compensation has relaxed the stressors requirement. If were in-country in a war zone, it is now considered a stressful place(really?) and there are no geographical limitations. In a Military Sexual Trauma claim, a detailed written statement by the victim is given equal weight for the claim without need for witnesses. MST is also included in the new DSM-V criteria for PTSD. She did emphasize that the best way to get PTSD rated (if think you qualify) is your need to accept help and report your true symptoms. She also mentioned aid and attendance compensation for those veterans that are aging and need help in their homes for daily needs. If you know someone who is having difficulty with living in their home alone, this may be something you need to research and contact your local veteran service office for help.

The second guest speaker, Dick Cole, is from a Michigan marketing firm that represents our California VVA for California Veterans Benefits Fund in solicitation. 93% of solicitation is through the mail and the other 7% is via telemarketing. The VBF is instrumental to each VVA chapter for funds that help the chapter function. The economic climate for donations in the last three years has been down. However, in the last four months donations have increased 15%. It is clear that each chapter does need to be responsible for as much of their donations and working expenses as possible. We are seeing that some chapters that are more successful are helping out other chapters with financial assistance.

James Maddox, VVA member from Pasadena, works tirelessly on the Veterans Health Council and supports bridging veteran information with the NAACP. He emphasizes that most people don't know who the VVA is.

#### John Crooker gets sworn in as Vice President of the California State Council



The board of the California State Council of VVA appointed John Crooker as First Vice President. He was confirmed by the attending members of the CSC on May 4, 2013. He will finish the remainder of Dennis (Doc) Croucher's term.

John joined VVA Chapter 223 in 1996 as a Life member. He served 3 terms as chapter treasurer, finance committee member and chair, and three terms as president of the Redwood Empire Chapter. He was editor of the chapter newsletter for 2 years. John has been a chapter delegate at the last four National Conventions, and he is the Treasurer for Sonoma County Vet Connect (veterans outreach).

Crooker helped with fund raising thru a Golf Tournament, Welcome Home Iraqi and Afghanistan Veterans BBQ.

John is on the San Francisco VA Hospital's "Veteran and Family Advisory Committee" and "The Hospitals Veterans Homeless Outreach Committee." He also serves on an advisory committee to the Sonoma County Board of Supervisors in regarding the Veterans Memorial Buildings and the overall welfare of the veterans in the county.

Crooker served in the Army from 1967-1972. After advanced infantry training he was sent to Vietnam in March of 1968. He was assigned to the 1st infantry division 1st/16th. John was a crewman on a 106 mm recoilless rifle. He was promoted to sergeant E-5 in September of 1968. His unit was transferred to the 9th infantry Division in November of the same year. He was assigned as a squad leader with the 5th of the 60th Inf. HQ/HQ company and was in the battalion commander's security platoon. John earned a CIB, a bronze star and a good conduct medal and received an honorable discharge.

He would like each chapter to reach out to our local NAACP chapter. There are over 2200 branches. There are many Vietnam veterans within this group. He has great success in the southern California area with sharing information with local NAACP chapters. James states that our VVA position; focus on policy and not politicians and health care initiatives, is in sync with their goals.

Our VVACSC website is a wealth of information. The message board is quite informative. We always take time at these meetings to hear what each chapter is doing via their chapter reports as well as the committee breakout sessions. I would encourage each of you to check out the VVACSC website and also to look at each chapter's website for their local news.

#### LOCAL ASSISTANCE FUNDING FOR COUNTY VETERANS SERVICE OFFICERS

SB 296 seeks raise the state's local assistance appropriation for County Veterans Service Officers by \$5 million. This would result in a total local assistance amount of \$7.6 million. SB 296 will also make available an additional \$1.4 million for competitive grants that the California Department of Veterans Affairs can award to Veterans Service Organizations, such as the American Legion, for outreach and claims assistance.

SB 296 passed out of the Senate Veterans Affairs Committee unanimously. The bill will next go to the Senate Appropriations Committee.

SB 296 is authored by Senators Lou Correa (D-Santa Ana) and Ben Hueso (D-San Diego).

## Vietnam Era Ends: May 7, 1975

From August 5, 1964 through March 28, 1973, many of you, our Veteran brothers and sisters were among the 8,744,000 active duty U.S. military personnel who proudly served our Nation during the war in Vietnam, with 2,594,000 of you serving within the borders of South Vietnam, some deployed as early as 1954 and leaving as late as 1975. The Vietnam Era also includes all Veterans who served in the Republic of Vietnam as early as February 28, 1961.

Over several years beginning in the early 60's, the U.S. escalated its forces in the Vietnam war assisting South Vietnam in opposition to communism - to deter Soviet-based expansion and control throughout Southeast Asia.

Aug. 2-4, 1964, after the Gulf of Tonkin incident, the Johnson Administration escalates U.S. involvement in the war.



Operation Rolling Thunder & Operation Starlite (65-68): By the end of 1965, there was a build-up of U.S. troops from 184,000 to 429,000 in 1966, and by 1968 there were 529,000 Americans fighting in Vietnam.

Vietnamization (69-74): With Nixon elected as president, the U.S. began a slow disengagement from the war, while building up the South Vietnamese Army to fight on its own.

On January 27, 1973 the Paris Peace Accords were signed declaring a cease-fire in Vietnam. The U.S. government, South Vietnam and North Vietnam governments pledged to "respect the independence, sovereignty, unity, and territorial integrity of Vietnam as recognized by the 1954 Geneva Agreements on Vietnam." As a result, there was a complete withdrawal of U.S. troops by March 29, 1973. At the end of the war, over **58,200** American soldiers had given their lives fighting for our country.



# VVA's Education Committee "The Living History Project" High marks at Santa Rosa Junior College and Santa Rosa High School By Bruce Thomson

April was a busy month for the 'project' with both the high school and the junior college hitting Vietnam this time of the year. We started at the J.C. in two classes for Jill Kelly-Moore, Humanities Faculty Instructor in her American Cultures classes. In each class we had three speakers share their Vietnam experience, then return in a week to judge a debate by the students on the pro's and con's of the war. The class stops the war at TET 1968 for the debate. We Vets judge the debate, not the war. This year the Pro side won the first debate while the antiwar side took the 2<sup>nd</sup> in a close vote. Both sides in the classes worked hard on their research and presentation. The 'Project' wishes to thank Kate Palmer-O'Hare, Dan Stover, John McGivney, Bill Burke & Bruce Thomson for their participation; we received an A+ from the teacher for our work.

At Santa Rosa High School, Terry Swehla coordinated with Art Horner, instructors for a day long experience with the junior history classes. We started at 08:00 and spoke to 474 students in 13 classes during the next 7 hours. Since we used the library all day, we also set up visual effects – helmets, medals and pictures adding a little more to the students exposure to our experiences. This year we had the privilege to display "Sentinels - Selected Portraits of Veterans of America's Wars" by Mike Dowdall, a talented Vietnam Veteran artist.

We used 2 or 3 veterans per period sharing our stories and answering student questions. A truly rewarding experience for both speakers and listeners. I can't thank enough, Steve Wiegert, Sunny Campbell, Dan Stover, Joe Ross, Bruce Thomson, John Logan, John McGivney, Bill Burke, Tom Dundas, Bob Evans, and Gene Campagna for their time and interest. We were well received with the students telling us how rewarding it was for them, not just another page in a book. We received an A+ from the faculty for our varied approach, amazing visuals, timing and candidness.



## **Dogs Helping Veterans**

**Canines Help Vets Cope with PTSD**

Since 1980, when the American Psychiatric Association added PTSD to its Diagnostic and Statistical Manual of Mental Disorders (DSM-III), clinicians have had many treatment regimens with varying levels of success. Some conventional treatments have had adverse effects on patients and made the symptoms worse.

The idea of service dogs as a treatment for PTSD has slowly been gaining the attention of mental health professionals who deal with PTSD. Dr. Bonita Bergin invented the concept of the Service Dog to assist people with mobility limitations in 1975. Bergin University of



Canine Studies, home of The Assistance Dog Institute, was founded by Dr. Bergin in 1991. Bergin University is the only accredited academic institution in the world solely dedicated to advanced canine education and research. The University is a leader in the field of canines assisting psychologically-scared veterans.

The University has two programs that assist veteran's needs. The Paws for Purple Hearts (PPH) program is the only program of its kind in the world and builds on the time-honored tradition of soldiers helping soldiers. This program helps heal returning combat veterans by teaching those with psychological scars, including PTSD, to train service dogs for their comrades with physical disabilities.

Another program, Dogs Helping Veterans, was started by Steve Moore, an Iraq war veteran and a graduate of Bergin University. This program joins vets with service dogs in training. Working with the dogs has many positive effects for the dogs provide a powerful (Cont'd on page 10)





intervention for people by giving them unrequited love and comfort and enhanced personal growth. People suffering from PTSD find themselves showered with love and returning love and devotion to their four-legged best friend, a relationship which can unravel the psychological knots twisted in war.

Researchers are accumulating evidence showing that bonding with dogs has positive biological effects and can serve as an effective therapeutic tool for veterans with PTSD and other psychological illnesses. A lot of this research is cutting edge and, as with any new treatment methods, is meeting with skepticism by some in the mental health field.

The staff, volunteers, and students at Bergin University, together with their four legged friends, are dedicated and deeply committed to the inclusion of service dogs as helpers for veterans with PTSD. The process has many therapeutic benefits and can enhance sociability.
