Presidents Message:

The more things change the more they stay the same. I have been making comments so I must make myself clear on a point. I do put a lot of thought into the position of expanding the membership in VVA and eventually, maybe changing the organization with renaming it. I believe that the work that we began many years ago is not complete and we may not live long enough to see it through. Our children and grandchildren may depend on our ability to work into the future.

As a lot of you are aware, I have been involved with the leadership at all levels of VVA since 1988 and have served on the board at all levels. I have been involved and served on many committees during this time. I often read and hear from members that insist that we are a last man standing organization and I appreciate that. I understand where most of them are coming from.

VVA was formed because no one understood us, and other organizations did not want to listen to our problems. After many years of fighting the government we were accepted because of our successes that benefited all veterans. Our founding principle of "Never Again Shall One Generation of Veterans Abandon Another" seems to have different meaning to different people. This is okay. I have served on committees that were tasked into looking into the ability to create a new organization, open our membership and other ways of making sure our ability to work with members of con- and go to work. Some did just that. gress and the VA can continue. Do not think that this is the first time this issue has been brought up. It was around for the conventions in 2005 and 2007. Look back through the VVA history to see what became of those questions. We have been the lone organization to work with a few startup groups to benefit post-Vietnam veterans. We have always been open and ready to listen and assist veterans in their search for

where they belong.

I hear all the comments about the "younger veterans" do not want to join an organization, they're not ready to join, when you get a membership they don't participate. I don't believe that is completely the facts of life. When you came home did you join? Were you welcomed into organizations? Were you too busy to participate or was it something else? The first organization I was asked to join was the VVA in 1986. I was welcomed and accepted. "I was just a truck driver," was my introduction to the members. In those days we introduced ourselves and said what we did during the war. When running for a chapter office, or any office at that time, what you did in the military was important. We are mostly passed that now.

Our military service is still important to us, we do have a faction that only acknowledges "boots on the ground" and another faction that is more into combat only, but we do all work together. Our commonality is that as different as we are, we are the same and can work together for the betterment of all veterans, so why the battle?

To most, coming home and not being acknowledged for our service was a slap in the face. After all we grew up watching all the movies about how returning veterans were treated with honor and respect. Most try not to remember that it was the old veterans and our families that turned their backs on our accomplishments, injuries and needs. We were told to get over it

Some were broken and did not understand what went wrong and went into hiding in work, or substance, to keep from feeling or remembering.

All in all, we have traveled down a path that may be longer than we expected. We passed a law in 2016 that has not been implemented yet. Public Law 114-315, the Toxic Research Act. This law was to take affect and be implemented over a year ago. With the cuts in staffing at VA hospitals we are being outsourced to whatever is cheapest. They increase the VA budget, but they use the money to outsource care and cut research and advancements in veterans care. Try to find a doctor on the outside that understands the trauma that veterans have gone through. Try to find a mental health program that can listen to your stories and not only understand but not judge. We need someone to carry on our mission and I am committing myself to help find or create that group that will not only honor us but take the mission and work to complete it.

It is okay if you disagree with me, it is okay if you oppose what I am doing. If you see things differently let me know, if you wish to assist let me know. This is our journey and we can make it a smooth one or we can bounce all the way to the end.

The museum will be replacing the WOWC Air Show this year with an assortment of smaller events so please visit our website <u>pacificcoastairmuseum.org</u> for information.



I asked Howard Berry to send you an article. Howard is father to Josh's Berry and Howard created this flag display after his son Josh took his life due to PTSD.

The 660 flags are a representation of the 22 soldiers who take their lives each day due to PTSD they suffer from their military service. The display will stay up for 30 days, at Santa Rosa Memorial Park Cemetery.

My son Sgt Raymond James Burnside took his life after seeking help from the VA.

We buried him on Valentine's Day 2016 so that is the day dedicated to display the flags the past three years.

Stan Dennison gave a presentation to the members about accessing free telephones for hearing impaired. I thought that putting out the information we would have had more members attending to get this information or sign up for the phones. I will put his contact information in the newsletter for a few months to encourage members to take advantage of this. Stan and I were a little disappointed with the turnout.

Upcoming events for March and April include Saturdays from 8:30 till 1 we will have a booth at the Farmers Market at the veterans building in Santa Rosa. This will be an information booth where we can sell tickets to our events and give information on whatever the volunteers are most comfortable with. We do have flyers and handouts available.

The first Thursday of every month is the Continuum of Care meeting at 12"30 till 1:30 at the county housing authority building on Guerneville Rd. This is an information exchange on housing programs for homeless veterans, beds available and working with the agencies in the county to house veterans and keep up to date on the changes in programs. Interested people are welcome to attend you can contact me for more information.

Second Monday of each month is the Veteran and Family Advisory committee. This committee meets at the clinic with the management and others discussing better ways to serve the veterans.

We are instrumental in putting on the Town Hall meeting with the VA leadership every May, this year on the 19th at the Santa Rosa Veterans building. We also take concerns from veterans we talk with to the committee and the relevant parts of the VA.

The second and fourth Thursdays are food distribution (probably not the best title) at the veterans building. Volunteers can contact Joe or Tony for more infor-

mation.

March 28th is our annual BBQ. We have the Jackass Flats campground all day and BBQ starts at 1PM.

Other dates for the month. March 10th Board meeting 1 PM, March 17th General Meeting (nominations open for officers and state council representatives), March 25th UVC meeting 7 PM Santa Rosa vets building. April we do all the regular things again. Board April 14th, general meeting April 21st, national board meeting April 17 and 18 with travel days before and after, April 22 is All Veterans day at the capitol. Ask me about getting registered.
