

# **Awards Dinner with San Quentin Veterans Group**

On July 11, 2017, Kate and Bill participated in the awards dinner at San Quentin State Prison. The veterans group at the prison has been in existence for many years and they sponsor fundraisers for scholarships and other worthy causes including Toys for Tots. We were met at the Gate by Madeline Tenney who is the veteran's group sponsor. She works with-



the system as the Medical Budget Analyst. We joined up at the main gate with four young Marines that were participating in the event as well.

Our walk through the quad area revealed a memorial area and a flag kept permanently at half staff for those correctional officers that had lost their lives in the line of duty at the prison. The hedges and annual flowers are maintained by the inmates. You could look across the area and see the old façade of the hospital from the original building structure that has been maintained for historical significance. We went to the Chapel area for the event. James "Shorty" Dunbar, a VVA member, greeted us and introduced us to many of the members. There was a blues band playing music while we mingled and went through the buffet line for dinner. We were able to meet and greet almost 50 members of the SQVG. They all made us feel welcome and it was an honor to shake hands with all of them.

Shorty is a member of VVA and he has written many articles for both the Veteran and the Zephyr. He read one of those as part of the ceremony. Another SQVG member, Shiloh, read a very moving poem reflecting on time served in Vietnam from the prospective of where his boots went. He served in the 173<sup>rd</sup> for one tour, was injured and sent to Hawaii for recuperation. While there, he was recruited to become a helicopter warrant officer, trained at Ft. Rucker and went back to Vietnam for another tour where is shot down again and injured. Greg is another member who has spearheaded a Wednesday night Wellness group with mod-

ules that they work through for various levels of healing. This is the group that Sunny Campbell of Chapter 223 meets with and sponsors.

The Marines that were there were presented with a check for over \$4,000 for the Toys for Tots program. This money is collected by selling pizzas and other food items to the inmates. It is amazing how they accomplished this.

Each of us six guests was given an opportunity to give a two minute talk about their military service. As you can imagine the most interesting stuff came from Kate. She is always the most interesting although the four active duty marines (1 E6 and 3 E5's) were very impressive since all have been in service from 5 to 8 years seeing action in Afghanistan and many other places as well. They also looked very smart in their dress uniforms and way too young.

It turns out that this Awards Banquet was the first one in three years that was held. We ate the same food as the general population ate that evening. Our group had two significant improvements however. There was a second protein item of a chicken wing and breast (paid for with the funds that Chapter 223 manages for the SQVG) and a second dessert. Other items included a Mac'N'Cheese item, corn, meatballs and one other item that is gone from the memory bank. Desserts included a very good chocolate cake and an apple betty As intuitional food goes it was pretty good. Both Kate and Bill cleaned their plates commenting that we've both had much worse food during our military life especially in a combat zone!

The program continued by awarding certificates of appreciation to several non-SQVG members that have helped the group carry out their various programs.

After the dinner, we were given an opportunity to go on a tour of part of the prison. We were able to see the spectacular murals in the prison main chow halls. Painted by a prisoner that took over 8 years working at night they cover the walls of 2 dining areas. They are over twenty feet tall depicting life during the World War II era. The murals were explained by a prison guard name Sgt. Al. He is in charge of the chow hall and is an imposing figure at 6'5" and over 300 pounds and has been doing the job for over 20 years. **Article continued on page 4**

During the past four to six years I have been a member of the Santa Rosa Vets to Vets group. We have been meeting at the Santa Rosa clinic for many years, even before we became a Vet to Vet group. We have been suffering from low numbers for a long time. It seems that doctors at the clinic do not want to refer veterans to our group. There are no clinicians running our group. It is a veterans group that serves veterans. We are now moving our group to the Santa Rosa Veterans Building. We have given this a lot of thought and discussion. We have been meeting on Thursday at 4:30 till 6 at the clinic. We will now be meeting at the Vets Building at 4:30 till 6 on Thursday's. We are thinking that we can get a few more veterans that would like to join a support group for veterans if we move our location. There are a number of our members that have

taken facilitator training to be able to run this group. If you have any interest in this group let me know.

Kate and Bill sounded like two jabbering monkeys on the ride home just trying to remember half of what we experienced.

VVA Praises Senator McCain; Wishes Him Well in His Battle Against Brain Cancer

(Washington, DC) – "John McCain is a fighter who endured brutal treatment as a prisoner of war in Vietnam, and we know he'll be a fighter now in his battle against brain cancer," said John Rowan, National President of Vietnam Veterans of America.

"On behalf of the members of VVA, and our families, we offer our prayers and sincere wishes to Senator McCain for as complete a recovery as medical science deems possible," Rowan said. "His fighting spirit will serve him well now, as it did forty-five years ago in the Hanoi Hilton and other hell holes.

"We are saddened to learn that yet another Vietnam veteran has been diagnosed with aggressive brain cancer. Vietnam veterans are all too familiar with glioblastoma, which seems to visit our brothers and sisters at a far greater rate than our non-veteran peers. For years, we have suspected that our exposures during our military service have caused this cancer cluster. Unfortunately, brain cancer is not on the presumptive list for exposure to Agent Orange, despite the efforts of our fellow veterans and their family members.

"The Senator's integrity and determination to do the right thing for America, as well as for his constituents, has been the hallmark of his more than thirty years as a legislator," Rowan said. "And we hope that he'll be able to return to his office and continue his service to America."

#### State Parks

Sergio Mondragon-Lopez Veterans Housing and Homelessness Prevention Program, Manager

There are updated instructions on the State Parks - Distinguished Veteran and Disabled Discount Pass Exchange Program. The process is really simple and takes about 10-15 minutes. Attached is a list of locations were veterans can exchange their passes. From the Pass Exchange website:

Starting June 15, the California Department of Parks and Recreation (DPR) will be issuing new credit card design passes for current Distinguished Veteran (DVP) and Disabled Discount (DDP) pass holders as part of its transition to California's new reservation system: ReserveCalifornia.

#### What to Bring:

If you have a Distinguished Veteran Pass, please bring the following documentation to a designated state park location:

Distinguished Veteran Pass (copies not accepted) <u>AND</u>

- · Valid California Driver License or California Identification Card showing veteran's current California residence address (interim/temporary not accepted) AND
- · Valid U.S. Department of Veterans Affairs Veteran Identification Card.

If you have a Disabled Discount Pass, please bring the following documentation to a designated state park location:

- · Disabled Discount Pass (copies not accepted) AND
- · Valid state-issued driver license or suitable photo identification (interim/temporary not accepted) issued by the state, federal government or a school <u>AND</u>
- · Department of Motor Vehicles (DMV)

Permanently Disabled Status. Valid non-joint vehicle registration stating disabled status/license or valid Disabled Person Placard Identification Card/Receipt containing the name of disabled person (copy of placard will NOT be accepted) OR

Ask your physician to complete the Doctor Certification in Section III of our Disabled Discount Pass application. The DDP application is located on DPR's website at <a href="www.parks.ca.gov/passes">www.parks.ca.gov/passes</a>.

#### What to Expect:

- DPR staff will help you set up a new <u>ReserveCalifornia</u> profile which you can start using on Aug. 1, 2017.
- Once your profile is created and your discount pass eligibility validated, DPR staff will give you a receipt that will serve as your temporary pass while your new credit card style pass is mailed to you from DPR's Pass Office (within 14 days of the date of exchange).

Current pass holders under the DVP and DDP programs may continue using their passes for camping reservations through July 31, 2017. Individuals may also use their current pass for day use through Feb. 28, 2018. Old passes will not be valid after these dates. Veterans: We need your help. SB 725; pretrial diversion, having passed out of the Assembly and Senate, is now headed to the Governor, where he can sign or veto the bill. SB 725 is one of the top veterans bills this year and is supported by all of the major veterans organizations.
